Remarks:

The 1,338,000,000 new Domestic Shares represent approximately 16.75% of the total issued Domestic Shares, which is calculated based on the Bank's total number of issued Domestic Shares (i.e. 7,987,933,539 Domestic Shares) before the issuance of new Domestic Shares. The 1,338,000,000 new Domestic Shares represent approximately 13.23% of the total issued ordinary Shares (including both Domestic Shares and H Shares), which is calculated based on 7,987,933,539 Domestic Shares and 2,125,335,000H Shares before the issuance of new Domestic Shares.

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *"Identical" means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
